

**REQUEST FOR QUOTATION
FOR THE PROCUREMENT OF COMBO AIR CONDITIONING/HEATING UNITS
FOR THE CHANCERY AND THE OFFICIAL RESIDENCE
AT THE PHILIPPINE EMBASSY IN CANBERRA**

The Philippine Embassy in Canberra, through the authorized appropriations under the General Appropriations Act, intends to apply the sum of **Sixteen Thousand Four Hundred and Ninety-Nine and 95/100 Australian Dollars (A\$16,499.95) only**, being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of combo air conditioning/heating units for the Chancery and the Official Residence at the Philippine Embassy in Canberra.
