INVITATION TO BID FOR THE DISPOSAL OF A USED MOTOR VEHICLE

Disposal of Government Vehicle with Active Diplomatic Registration

The Property Disposal Committee (PDC) of the Philippine Embassy in Canberra, Australia invites all interested parties to participate in the public bidding for the sale, on an "**AS-IS, WHERE-IS**" basis, of the following embassy vehicle:

III. TERMS AND CONDITIONS

1. **"As-Is, Where-Is" Basis:** The vehicle is sold in its current physical condition without any warranty, expressed or implied, as to its mechanical state or roadworthiness.

2. **Bid Bond:** All bids must be accompanied by a Bid Bond in the form of Cash or Bank Cheque or Debit/Credit Card payment equivalent to ten percent (**10%**) of the total bid offer. Bids without the required bond shall be automatically disqualified. Auction bonds of non-winning bidders shall be returned immediately after the announcement of the winning bidder.
3. **Currency:** All bid offers must be written and paid in Australian Dollars.
4. A bidder shall accomplish the auction tender in at least three (3) copies. The envelope containing the Bid should be sealed and addressed to the Chairperson of the Disposal Committee of the Philippine Embassy in Canberra, Australia. It may be submitted by mail or delivered at Philippine Embassy, 1 Moonah Place, Yarralumla, Act 2600.
5. Qualified bidder shall submit his/her Bid, indicating the description of the motor vehicle with the corresponding bid offer in figures and in words.
6. **Award and Payment:** The vehicle will be awarded to the highest complying bidder whose offer meets or exceeds the minimum floor price. The winning bidder must pay the remaining balance within **five (5) working days** from the receipt of the Notice of Award.
7. **Forfeiture:** Failure of the winning bidder to pay the balance within the specified period shall result in the forfeiture of the 10% Bid Bond in favour of the Philippine Government.
8. **Taxes and Deregistration:** All costs related to the transfer of ownership, registration, local host-country taxes, duties, and the physical pulling-out/towing of the vehicle from the Embassy premises shall be borne exclusively by the winning bidder.
9. **Reservation Clause:** The Embassy Property Disposal Committee reserves the right to reject any or all bids, to waive any formality found therein, or to accept such bids as may be considered most advantageous to the Philippine Government.

IV. SPECIAL CONDITIONS FOR ACT REGISTRATION

1. The Embassy will remove and retain the "DC" Diplomatic Corps plates and surrender it directly to DFAT Protocol. The Vehicle will not be released with diplomatic plates attached.

2. The vehicle is sold without an ACT Roadworthy Certificate (RWC). Upon completion of the sale, its diplomatic registration will be cancelled. Consequently, the vehicle **cannot be driven on public roads in the ACT without the necessary permit**. The buyer must arrange a flatbed tow truck or secure an Unregistered Vehicle permit from **Access Canberra** at their own expense.
